

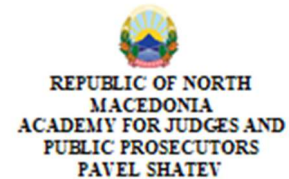

Introduction

Target group: The webinar is aimed at court officials, legal practitioners, lawyers, mediators, judges, representatives of the Ministry of Justice.

Description: This training presents an overview of how innovative technologies are used in criminal proceedings. In the first part of the training, we provide an overview of the international and EU legal and policy framework relevant to digital criminal justice. Next, we discuss some key practical uses of digital technologies, from court’s document classification, to data analysis and visualization. In the second part of the training, we discuss the ethical and legal challenges related to the use of digital technologies in criminal proceedings. In particular, we focus on the impact of digital technologies on court judgements, on data protection and fundamental rights.

Method: The webinar will be delivered as a synchronous online training with simultaneous interpretation via the platform ZOOM.

The programme of the webinar is composed by a series of presentations introducing the key legal issues, questions and answers periods and a couple of short case-studies.
